Success Stories from HOA representatives attending meeting:

1. An HOA successfully removed a standalone basketball hoop located on the common area (berm) in front of a home. No one claimed ownership and the HOA had Apple Valley Waste remove it.
2. An HOA sued a bank for unpaid assessments on lots owned by the bank. The HOA and the bank successfully reached a settlement agreement for the past due assessments and as the lots are sold in the future all assessments due on each lot will be paid to the HOA.
3. An HOA which had been dormant for about 10 years, recently re-registered with the Secretary of State and is in the processing of electing a Board of Directors and writing policies of enforcement for their community.
4. An HOA Board was approached by children in the community to install a bike rack at the bus stop. The Board considered the request and a bike rack will be installed.
5. A homeowner in a community was denied a request for a satellite dish by the Declarant. But when the Board pointed out the inconsistency of the denial when many other satellite dishes had already been installed, the Declarant approved the request upon the condition that the homeowner plant a small bush to hide the dish from public view.
